Sir / Madam,

I am enclosing a copy of Memo. No. 302(20)-RD/O/NREGA/18S-03/10 dated 10.10.2013 issued by Shri Saurabh Kumar Das, IAS, Principal Secretary, Panchayet & Rural Development Department, Government of West Bengal. It has been informed in the above memo that job seekers under MGNREGA may be engaged in schemes implemented in the premises of primary / secondary schools involving environmental improvement and cleaning activities.

It has been brought to notice that even now such activities in schools are not being carried out in some districts. You are requested to accord priority to this and engage job seekers under MGNREGA in secondary / primary schools for cleaning activities and environmental improvement in the schools premises.

District Inspector of Schools (Secondary Education) and District Inspector of Schools (Primary Education) may ask respective S.I. of Schools / Headmasters to contact the relevant officials of Block level so that job seekers under MGNREGA are engaged in much needed activities of cleaning and environmental improvement in schools. D.I. of Schools will send monthly report on number of personnel provided by MGNREGA to schools in the district. This report should reach the Commissioner of School Education within 5<sup>th</sup> of each month for the preceding month.
