Sir,

Mahatma Gandhi NREGA implementation in West Bengal follows a specific pattern of staffing at the district level. Accordingly, for the newly created districts of Paschim Bardhaman and Jhargram for which the District Magistrates were already notified as the District Programme Coordinators vide this office Memo.No.2601-RD/O/NREGA/18S-03/09 dated 16.05.17 and 2602-RD/O/NREGA/18S-03/09 dated 16.05.17 respectively will also have the following staffing pattern to support MGNREGA implementation.

The recruitment to contractual posts will be governed by the existing G.O. and the entry point remuneration of the said employees will be fixed after adding 9% enhancement as permitted by Finance Department with pre-revised rate of remuneration.

In case of bifurcated districts, the existing contractual employees of the undivided district will be given an option to indicate their choice of posting in either of the two districts. Only after deciding on their options, actual vacancy shall be determined and the process initiated for contractual agreement.
