Sub: Observation of plantation week from 29.7.2018 to 4.8.2018

You are requested to take a week-long initiative for plantation works using MGNREGS fund at all Gram Panchayats and Blocks from 29.7.2018 to 4.8.2018. Other funds where available may also be included. The works will be taken up by Gram Panchayats as PIAs. Before the said period major plantation works should be completed. By the end of the said week all plantation works for the financial year 2018-19 should be completed.

All available fallow land under the control of the Government, Gram Panchayats, Panchayat Samiti, Schools, ICDS, Health Centres, land besides rural roads etc. should be identified for plantation. Assessment of no. of plants and species required, its availability, purchase plan from govt. nurseries are to be made expeditiously. In every such case plantation must be followed by 'Brikshapatta' and they should be given proper training regarding their rights and duties. In case of IBS plantation, identification of beneficiaries and species according to their choice and soil condition should also be kept in mind. For better survival rate, saplings of one-year age or of standard size should be preferred. The ADA of the Block and horticulture staff are to be associated. The pit cutting should be completed well before.

In each Block the programme should be launched centrally in a Gram Panchayat in presence of Gram Panchayat and Panchayat Samiti office bearers and members, Block level officials of different departments, SHGs, AWCs and ASHAs and local people etc. on 29.7.2018. The Hon'ble MLAs and Zilla Parishad members from the area should also be requested for their august presence. It will simultaneously be launched at all Gram Panchayats. A wide publicity of the programme throughout the week will yield a good result. Please make documentation by professional photographers and send a copy in DVD with your report in the following format by 7.8.2018.
